MINUTES POINTE COUPEE PARISH POLICE JURY June 26, 2018

The Pointe Coupee Parish Police Jury met in regular session at 5:30 p.m. Tuesday, June 26, 2018, at the Courthouse Annex in the Police Jury Meeting Room, New Roads, Louisiana.

President Olinde gave condolences to the family of Mr. O. J. Bello, who passed away. He was the father of former Parish Administrator Jimmy Bello.

President Olinde called the meeting to order and directed Secretary Gerrie Martin to call the roll:

<u>DISCUSSION & CONSIDERATION OF PROBLEMS WITH SOLID WASTE COLLECTIONS IN THE PARISH BY REPUBLIC SERVICES</u>

Juror Dukes reported on discussions with representatives of Republic Services and that the problems with solid waste collections and carts in the parish have been resolved.

Public Utilities Billing and Collections Supervisor Linette Pascalin gave confirmation on the proposed corrective changes by Republic to address damage and replacement carts, and the collection of solid waste in the parish.

Mmes Sharon Mann and Karla Swacker of Republic commented on the proposed changes and reported they will be storing a truck and adding a new route in the parish.

Juror Jarreau recognized Mayor Rhett Pourciau of the Town of Livonia who voiced concerns about the collection of solid waste in the town by Republic. He was informed about the proposed changes.

Motion by Mr. Cox and seconded by Mr. Hurst:

RESOLVED, That Republic Services be allowed to store a solid waste collection truck at the Parish Maintenance Facility.

Unanimously carried.

RESOLUTION--AUTHORIZE THE PARISH TO JOIN IN THE NATIONAL LITIGATION IN RE: NATIONAL PRESCRIPTION OPIATE LITIGATION, AND RETAIN SPECIAL COUNSEL TO REPRESENT ITS INTERESTS IN SAID LITIGATION

Assistant District Attorney John Wayne Jewell presented the following amended resolution for approval of the Jury:

Motion by Mr. Smith and seconded by Mr. Hurst:

Authorizing the Parish of Pointe Coupee to join in the national litigation *In Re: National Prescription Opiate Litigation*, and to retain special counsel to represent its interests in said litigation, and to otherwise provide with respect thereto.

WHEREAS, this Police Jury agrees that in order to ensure protection of the Parish's interests, a real necessity exists such that it join the aforementioned litigation and that Special Counsel should be retained to assist the district attorney in prosecution of any and all claims the Parish may have against manufacturers and distributors of Prescription Opiate drugs for any fault of theirs in causing or contributing to the Opioid Crisis; and

WHEREAS, the Opioid Crisis has recently brought national attention and has impacted communities across the country, both large and small; and

WHEREAS, the Louisiana Department of Health ("DHH") has filed a lawsuit alleging "Louisiana is overrun with opioid analgesic pain relievers and engulfed in a public health crisis"; and

WHEREAS, DHH alleges that as a result of that crisis Louisiana citizens bear a cost of approximately \$296 million per year in healthcare costs plus costs and strains on the criminal justice system; and

WHEREAS, hundreds of lawsuits have been filed on behalf of government entities in the *In Re: National Prescription Opiate Litigation*, MDL 2804, multi-district litigation in the Northern District of Ohio; and

WHEREAS, this Police Jury has considered the attached retainer agreement and authorizes Special Counsel to receive as compensation for their services, reimbursement of reasonable expenses, as well as twenty percent (20%) of the first twenty million dollars and fifteen percent (15%) of any funds in excess of twenty million dollars; and

WHEREAS, this resolution shall take effect immediately.

THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Pointe Coupee, Louisiana, pursuant to La. R.S. 42:262, does hereby retain and employ the law firm of Gainsburgh, Benjamin, David, Meunier & Warshauer, LLC through its partner attorneys (Robert J. David, Gerald E. Meunier, Irving J. Warshauer, Michael J. Ecuyer, Walter C. Morrision, IV, and M. Palmer Lambert), its associate attorneys (Claire E. Berg, Rachel M.

Naquin, and Brittany R.Wolf), and paralegals/assistants (Kathy Sokol, Magan Ennis, Denise Martin, Beth Brown, Dara Delger, and Kristina Cantrelle), as Special Counsel; and

BE IT FURTHER RESOLVED, that this Resolution and proposed contract described herein be submitted to the Attorney General for the State of Louisiana for approval.
