### 22. Consider and take action on Committee Recommendations:

  - Amend the Personnel Policy Manual to remove Section 4.1 D stating "an employee failing probation shall have the right to appeal to the Personnel Committee within ten (10) days following notice of failure of probation, and the decision of the Police Jury shall be final."
  - Authorize Treasurer Becky Mayeux to consult a third party to evaluate the Personnel Policy Manual regarding health and safety to implement a gauge for heat index and breaks.
  - Approve advertisement of a Position Vacancy Announcement in the official journal for two (2) Equipment Operator II (tractor driver) positions and one (1) laborer position.
- 2. Public Utilities (Chairman Cline)
  - Approve increase in user rate from \$15 to \$25 for Legonier Sewer District, mail notices to customers about the rate increase and include a financial spreadsheet.
  - Approve increase of utilities bill cutoff notice rate from \$40 to \$60.
  - Approve increase of utilities reconnect fee from \$40 to \$60, and advertise a public notice in the official journal.
