<u>PUBLIC HEARING--AN ORDINANCE FOR TECHNICAL CORRECTION OF PRECINCT BOUNDARIES</u>

A public hearing to obtain input from citizens concerning an ordinance for a technical change by moving one census block from precinct 8B to 8A following reapportionment in the parish and to further provide with respect thereto was held at 5:10 p.m., Tuesday, January 24, 2012 at the Police Jury Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana. There being no objections received by the public, the following ordinance was approved by the Jury:

Motion by Mr. C. Dukes and seconded by Mr. Pourciau:

AN ORDINANCE

FOR A TECHNICAL CHANGE BY MOVING ONE CENSUS BLOCK FROM PRECINCT 8B TO 8A FOLLOWING REAPPORTIONMENT

BE IT ORDAINED by the Police Jury of the Parish of Pointe Coupee in regular session, duly convened, in keeping with the authority granted by applicable federal and state laws and regulations, and in order to affect reapportionment of its voting districts following the 2010 Census, that it does hereby enact an Ordinance for a technical change between Precinct 8A and 8B in order to comply with RS 13:2612, which refers to the alignment of the Justice of the Peace Courts and the Parish Police Jury Districts.

Census Block 22077951003068 shall be removed from Precinct 8B and placed in Precinct 8A.

The visible boundaries of the corrected precincts are hereby described as:

Precinct 8A: Beginning at the intersection of the centerlines of St. Augustine Street and St. Joseph Street, then proceed westerly along the centerline of St. Augustine Street to the centerline of New Roads Street; then southerly to the centerline of 13th Street; then westerly to the centerline of St. Mary Street; then southerly to the centerline of Parent Street; then westerly to the centerline of Poydras Street; then southerly to the centerline of Union Pacific Railroad track; then northwesterly to the centerline of Portage Canal No. 1; then northeasterly to the centerline of LA Hwy. 1; then southerly to the centerline of Portage Canal No. 1; then westerly to the centerline of St. Joseph Street; then southerly to the centerline of St. Augustine Street and the point of beginning.

Precinct 8B: Beginning at the intersection of the centerlines of St. Augustine Street and St. Joseph Street, proceed northerly to the centerline of Portage Canal No. 1; then easterly to the centerline of LA Hwy. 10; then southerly and southwesterly to the centerline of St. Augustine Street; then westerly to the centerline of St. Joseph Street and the point of beginning.

BE IT FURTHER ORDAINED that the TECHNICAL CHANGE in the Precincts established shall be effective with the receipt of the preclearance letter from the US Department of Justice, for all purposes.

SECTION 1. All ordinances or parts thereof in conflict herewith are hereby repealed.

SECTION 2. If any section, part, paragraph, sentence or clause of this ordinance should be declared invalid or unenforceable, such invalidity or defect shall not affect the remaining sections,

paragraphs, parts, sentences, or clauses hereof and, to this end, the several provisions hereof are declared to be severable.

INTRODUCTION OF AN ORDINANCE TO AMEND CHAPTER 19 OF THE PARISH CODE OF ORDINANCES TO ADD ARTICLE III, SECTION 19-22 PERMIT & SURETY BOND FOR ACCESS TO PARISH ROADS

Motion by C. Dukes and seconded by Mr. Jarreau:

NOTICE OF INTRODUCTION OF ORDINANCE AND PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the following ordinance has been introduced before the Police Jury of the Parish of Pointe Coupee, Louisiana, and that a public hearing will be held relative thereto at 5:00 p.m., Tuesday, February 14, 2012 at the Police Jury Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana, after which said ordinance may be considered for adoption. All interested persons are urged to attend.

AN ORDINANCE

To amend Chapter 19 of the Code of Ordinances of the Parish of Pointe Coupee, Louisiana relative to roads and bridges, to require permits and security for the use of parish roads in instances of heavy trucks and equipment and to further provide with respect thereto.

WHEREAS, it is becoming more costly to maintain parish roads and bridges; and

WHEREAS, one of the reasons for such cost is damage caused by heavy vehicles, equipment and loads; and

WHEREAS, it is equitable to require those who cause the most damage to be responsible for the maintenance and repair.

THEREFORE, BE IT ORDAINED by the Police Jury of the Parish of Pointe Coupee, Louisiana:

SECTION 1. Chapter 19 of the Code of Ordinances of the Parish of Pointe Coupee, Louisiana, is hereby amended and re-ordained by adding a new Article thereto to read as follows:

"ARTICLE III. USE OF PARISH ROADS BY HEAVY VEHICLES

* * *

Sec. 19-16. Use of roads by heavy vehicles; permits; permit fees; security

- (a) Individuals and Entities desiring to access parish roads, which are defined as those roads accepted into the parishwide system of road and bridge management, with heavy equipment, or equipment determined by the Police Jury that would cause damages to parish roads, shall first seek and obtain a permit from the Pointe Coupee Parish Police Jury, and shall post a surety bond in favor of Pointe Coupee Parish in order to access parish roads.
 - (b) Individuals or entities seeking such permits shall apply therefor to the parish department

of public works. This permit shall be purchased at a cost of fifty dollars (\$50.00) per site from which access will occur. Additionally, applicants shall submit with the application a surety bond in favor of Pointe Coupee Parish Police Jury for each access site in the sum of fifty thousand dollars (\$50,000.00).

- (c) Heavy Equipment is defined as any equipment greater than twenty-five thousand pounds (25,000 lbs.) in total weight, including cargo.
 - (d) Farming operations shall be exempt from the requirements of this Section.

SECTION 2. If any section, part, paragraph, sentence or clause of this ordinance should be declared invalid or unenforceable, such invalidity or defect shall not affect the remaining sections, paragraphs, parts, sentences, or clauses hereof and, to this end, the several provisions hereof are declared to be severable.

SECTION 3. All ordinances or parts thereof in conflict herewith are hereby repealed.

Unanimously carried.

WHEREAS, the plans and specifications for the LRA--CDBG Gustav/Ike Disaster Recovery Program - Town of Livonia Civic Center Improvements (Pavilion at Glaser Park) have been completed and the Architect reports that the project is now ready for advertisement of bids: Therefore be it

RESOLVED, That the Pointe Coupee Parish Police Jury hereby authorized Mougeot Architecture to advertise for bids for said project; and be it

RESOLVED further, That the bids are to be received at the office of the Police Jury at the date and time established by the Police Jury.

COMMITTEE REPORTS:

PERSONNEL

The minutes of the Personnel Committee meetings held January 17, 2012, were given to each Juror for

their review.

At the request of Juror A. Dukes, Chairman Cox gave an explanation of why the committee recommended President Bueche send him a letter and discussions of incidents that occurred warranted the letter. He also reported the committee discussed the importance and needs to change policies and procedures for the Jury and develop structures for employees to address future incidents.

Juror A. Dukes voiced his displeasure about the actions taken and recommendations of the committee toward him to be reprimanded by the Jury. He stated that Recreation Director Sal Genusa approached him after the last Jury meeting, and he did not approach Mr. Genusa.

Juror C. Dukes informed the Jury Ms. Sheri Hunter, who resides in his district, attended the Personnel meeting in December to only give a report on the incident that occurred in November at the Recreation Park.

President Bueche reminded Jurors that the Jury is a legislative body, therefore, when criminal charges are filed or possible litigations occurred they are advised to refer these issues to the District Attorney's Office. She also stated that as Jurors they have a responsibility to prevent a hostile environment for employees, and they should not interfere with the daily operations and tell employees in the administrative office what to do.

Juror A. Dukes stated that if he is the only Juror to receive a letter from the President, then he will personally sue every Juror for slander, if there is no proof presented that he did anything wrong because he requests documents from employees.

Parish Administrator Bello stressed to the Jury that he has always treated Juror A. Dukes with respect and assistance, and never denied him any reasonable requests. Mr. Bello voiced concerns about him and some employees being subjected to constant interference and demands in the day to day operations by Juror A. Dukes.

Juror Vosburg stressed that the operation of the business and the Jury administrative office is very important, and no Juror should act alone or dictate and subject employees to a hostile environment, the Jury should act as a group.

Motion by Mr. Cox and seconded by Mr. Jarreau:

RESOLVED, That the minutes of the January 4, 2012 Personnel Committee be accepted to include an amendment that all employees will use the time clock daily, excluding department heads; and be it

RESOLVED further, That the recommendation from Parish Administrator Jimmy Bello, that no further action is warranted concerning an incident between Recreation Director Sal Genusa and Juror Albert Dukes be accepted; and be it

RESOLVED further, That President Melanie Bueche be authorized to execute a letter to Juror Albert Dukes reminding him of his duties and that he should refrain from directing the daily operations by employees; and be it

RESOLVED further, That the Jury supports the Parish Administrator in executing authority to address issues as such and to prevent access to the Jury employees or area by anyone that is acting outside of a policy or statute of the Jury or State; and be it

RESOLVED further, That the Recreation Director and the Parish Administrator have the authority to initially have anyone removed from parish property as deemed necessary to uphold the safety and peace of the citizens, and the Parish Administrator shall have the authority to prevent further access by the said individual if the future safety of the citizens are in question should the person return; and be it

RESOLVED further, That Secretary Gerrie Martin be allowed to type the Police Jury minutes

at her home the day after a Police Jury meeting; and be it

RESOLVED further, That the Police Jury lift the hiring freeze to advertise for an Animal Control Officer.

Substitute motion by Mr. A. Dukes and seconded by :

RESOLVED, That it be removed that President Melanie Bueche be authorized to execute a letter to Juror Albert Dukes reminding him of his duties and that he should refrain from directing the daily operations by employees; and it be removed that the Jury supports the Parish Administrator in executing authority to address issues as such and to prevent access to the Jury employees or area by anyone that is acting outside of a policy or statute of the Jury or State; and be it

RESOLVED further, That Recreation Director Sal Genusa be terminated from employment with the Police Jury.

The substitute motion died, due to lack of a second.
