A public hearing to obtain input from citizens concerning an ordinance to amend Chapter 4, Section 4-2 thru 4-5 of the Parish Code of Ordinances for Animals and Fowl and to further provide with respect thereto was held at 5:25 p.m., Tuesday, March 27, 2012 at the Police Jury Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana.

Comments were made by Jurors, Sheriff "Bud" Torres, Assistant District Attorney John Wayne Jewell and persons in the audience. Mr. Bob Allen voiced concerns about the ordinance. Jurors and Attorney Jewell made suggested changes to the ordinance. There were no objections received orally nor written.

FUNDING REQUEST FOR H.O.P.E. MINISTRY OF POINTE COUPEE

Treasurer Becky Mayeux presented a request to provide financial assistance to H.O.P.E. Ministry of Pointe Coupee in the amount of \$30,000.00 to assist with their 2010 Housing and Rehabilitation Grant from HUD for \$145,000.00, which is a reimbursable grant. She reported that HUD is asking the Jury to fund a \$10,000 loan per month to H.O.P.E. Ministry, to be reimbursed by the grant.

Motion by Mr. A. Dukes and seconded by Mr. Cox:

RESOLVED, That the Police Jury fund a \$10,000 loan per month to H.O.P.E. Ministry of Pointe Coupee for three (3) months to be reimbursed by funds received from the Housing and Rehabilitation Grant from HUD.

<u>PECAN ISLAND ROAD BRIDGE REPLACEMENT IN DISTRICT NO. 4 FOR THE FEDERAL OFF-SYSTEM HIGHWAY BRIDGE PROGRAM</u>

Engineer Kevin Gravois requested approval of the Jury to submit an application with the LA Department of Transportation and Development to request funding from the Federal Off-System Highway Bridge Program for the replacement of the Pecan Island Road Bridge in Juror District No. 4.

Motion by Mr. Cline and seconded by Mr. Pourciau:

RESOLVED, That Professional Engineering Consultant Corporation be authorized to submit an application with the LA Department of Transportation and Development to request funding from the Federal Off-System Highway Bridge Program for the replacement of the Pecan Island Road Bridge in Juror District No. 4 at Jarreau.

MASTER DRAINAGE PLAN LRA--CDBG IKE/GUSTAV DISASTER RECOVERY PROGRAM

Engineer Kevin Gravois reviewed and presented the Master Drainage Plan Summary of Local Drainage Projects in each Juror District for the LRA--CDBG Ike/Gustav Disaster Recovery Program to the Jury. Engineer Gravois asked Jurors to review the report for possible amendments. This matter was referred to the Public Works Committee to review the summary in detail for any adjustments.

PARISH ROADSIDE CLEANUP

Sheriff Torres and Parish Administrator Bello reported on implementing a parish roadside garbage cleanup by inmates throughout the parish. The cleanup will include twice a week collection on Tuesdays and Thursdays, one deputy and four (4) inmates. The Sheriff requested approval of the Jury to purchase a 20 ft. trailer, provide fuel, porta can and other needed accessories for the cleanup.

Motion by Mr. Cox and seconded by Mr. C. Dukes:

RESOLVED, That the Police Jury purchase a 20 ft. trailer, provide fuel, porta can and other needed accessories for twice a week collection of garbage to provide a parish roadside cleanup by inmates from the Sheriff Department, to be funded by the Solid Waste Fund.

Unanimously carried.

PURCHASE CHEMICALS TO SPRAY LILIES IN FALSE BAYOU

Juror Olinde requested approval of the Jury to purchase chemicals for LA Department of Wildlife & Fisheries to spray the lilies in False Bayou at a cost not to exceed \$1,500.00.

Juror A. Dukes asked that chemicals be purchased to spray Portage Canal.

Motion by Mr. Olinde and seconded by Mr. Cline:

RESOLVED, That chemicals be purchased at a cost not to exceed \$3,000.00 to spray lilies in False Bayou at Ventress and Portage Canal at New Roads.

Unanimously carried.

SPONSORSHIP FOR THE BOYS AND GIRLS STATE PROGRAM

President Bueche requested approval of the Jury to allocate \$1,600.00 as sponsorship for four (4) junior students from the high schools in the parish to attend the Boys and Girls State Program, sponsored by the Hunter Fabre American Legion Post and Auxiliary.

Juror Cline commented on Poydras Funds sponsoring one student to attend the Boys and Girls State Program.

Motion by Mrs. Vosburg and seconded by Mr. Cox:

RESOLVED, That the Police Jury allocate \$1,600.00 as sponsorship for four (4) junior students from the high schools in the parish to attend the Boys and Girls State Program, sponsored by the Hunter Fabre American Legion Post and Auxiliary.
