### APPOINT CONSTABLE IN POLICE JUROR DISTRICT 5 TO FILL UNEXPIRED TERM UNTIL ELECTION IS HELD

Motion by Mr. Olinde and seconded by Mr. C. Dukes:

WHEREAS, the members of the Pointe Coupee Parish Police Jury has accepted the resignation of Mr. Joseph A. Ballard, Constable, Justice of the Peace District 5, Parish of Pointe Coupee; and

WHEREAS, Mr. Ballard has rendered innumerable public service to his District, Parish and the

WHEREAS, the absence of this outstanding citizens to public service is keenly felt as a great loss; and

WHEREAS, the Police Jury wishes to appoint someone to replace Mr. Joseph A. Ballard: Therefore be it

RESOLVED, That Mr. Steve A. Stelly be appointed as Constable, Justice of the Peace District 5, Parish of Pointe Coupee, to fill the unexpired term of Mr. Joseph A. Ballard until an election is held.

# RENEGOTIATION OF LEASE REGARDING TWO BANK BUILDINGS FOR THE SHERIFF AT MORGANZA

Juror Jarreau introduced Mr. Brad Bergeron who presented a new proposal to renegotiate a lease regarding the two (2) bank buildings at Morganza that is currently leased by the Jury for the Sheriff's Office. The current lease will expire in December. This matter was referred to the Buildings Committee for further review.

Juror C. Dukes asked Mr. Bergeron to submit a proposal for a lease-purchase of the two buildings for review by the Jury.

#### RE-ESTABLISH A BIKE TRAIL FROM NEW ROADS TO OSCAR

President Bueche requested the support of the Jury to re-establish a bike trail from Oscar to New Roads. She reported the Tourist Commission will assist and participate in this endeavor. She reported that DOTD has offered to design and erect the signs for the bike trail, and she will seek donations to pay the cost to design the signs.

Juror C. Dukes asked the Jury to consider sponsoring an annual Pointe Coupee Parish Police Jury Bike Ride along the bike trail in an effort to promote historical travel and good health for the citizens. President Bueche will present this idea to the Tourist Commission.

Motion by Mr. C. Dukes and seconded by Mrs. Vosburg:

RESOLVED, That the Pointe Coupee Parish Police Jury hereby offers moral support to re-establish the bike trail from Oscar to New Roads in the parish.

REQUEST FROM THE PC COMMUNITY HOUSING & DEVELOPMENT ORGANIZATION FOR USE OF PARISH OWNED PUBLIC BUILDINGS FREE OF CHARGE FOR PUBLIC MEETINGS

### <u>UPDATE ON MASTER DRAINAGE PLAN - LRA HURRICANES GUSTAV/IKE DISASTER RECOVERY</u>

Mr. Thomas David, III of Pan American Engineers of Alexandria gave an update on the Master Drainage Plan for the LRA Hurricanes Gustav/Ike Disaster Recovery. After discussion and review of the plan, the following resolution was offered:

Motion by Mr. Jarreau and seconded by Mr. C. Dukes:

A RESOLUTION AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO THE OFFICE OF COMMUNITY DEVELOPMENT - DISASTER RECOVERY UNIT FOR THE FOLLOWING DRAINAGE PROJECTS AS DESCRIBED IN THE POINTE COUPEE SUMMARY OF LOCAL DRAINAGE PROJECTS - MASTER DRAINAGE PLAN DATED MARCH 2012 AND REVISED JUNE 2012.

WHEREAS, the Pointe Coupee Parish Police Jury has reviewed and accepted the Pointe Coupee Parish Summary of Local Drainage Projects Report as prepared by Professional Engineering Consultants Corporation for the Parish's Community Development Block Grant Disaster Recovery Program; and

WHEREAS, the Parish needs to identify the initial projects to be submitted to the Office of Community Development - Disaster Recovery Unit for funding under the Community Development Block Disaster Recovery Grant Program: Therefore be it

# AUTHORIZE THE PRESIDENT TO SIGN A COOPERATIVE AGREEMENT FOR THE LSU AGCENTER TO SUPPORT & ADMINSTER LOUISIANA COOPERATIVE UNITS OFF CAMPUS

# AUTHORIZE THE PRESIDENT TO SIGN A LOCAL JOINT SERVICES AGREEMENT WITH THE SHERIFF FOR OPERATIONS OF A CENTRALIZED COMMUNICATIONS SYSTEM (E911) IN THE PARISH

Motion by Mr. Young and seconded by Mr. Olinde:

Authorizing the Parish to enter into a local services agreement with the Pointe Coupee Parish Communications District, Pointe Coupee Parish Office of Homeland Security and Emergency Preparedness and Pointe Coupee Parish Sheriff under which a central communications system will be maintained in the Parish of Pointe Coupee and operated by the Pointe Coupee Parish Sheriff; to provide a method of funding therefore; and to otherwise provide with respect thereto.

WHEREAS, it is in the public interest to shorten the time required for a citizen to request and receive emergency aid; and

WHEREAS, various agencies and political subdivisions within the Parish of Pointe Coupee, Louisiana, previously employed communications systems which were not interrelated with one another; and

WHEREAS, a central communications system within the Parish of Pointe Coupee provides a significant contribution to law enforcement and other public service efforts by simplifying the notification of public service personnel, resulting in the saving of life, a reduction in the destruction of property, quicker apprehension of criminals and ultimately the saving of monies; and

WHEREAS, a joint effort of the various entities concerned with communications continues to be the most efficient, economical and effective method of achieving the employment of such a system; and

WHEREAS, the Pointe Coupee Parish Sheriff has undertaken and maintains the authority for the management of such a system: Therefore be it

RESOLVED, That the Police Jury of the Parish of Pointe Coupee, Louisiana, enter into a joint services agreement with the Pointe Coupee Parish Communications District, the Pointe Coupee Parish Office of Homeland Security and Emergency Preparedness and the Pointe Coupee Parish Sheriff under which the management and maintenance of a centralized communications system in the Parish of Pointe Coupee has been undertaken by the Pointe Coupee Parish Sheriff; and be it

RESOLVED further, That this Police Jury agrees to guarantee under said agreement the payment of \$125,000.00 annually as its share of the cost of said system; and be it

RESOLVED further, That Mrs. Melanie L. Bueche, President, be authorized to execute the joint services agreement on behalf of this Police Jury, a copy of which is annexed to and made a part of this resolution; and be it

RESOLVED further, That a copy of this resolution be transmitted to all other parties to said agreement and published in accordance with law.

Unanimously carried.

### PERMISSION TO ENGAGE ATTORNEY DANNIE GARRETT TO GIVE ADVICE TO THE JURY FOR A CONTRACT FOR OPERATIONS OF THE DETENTION CENTER

President Bueche requested permission of the Jury to engage Attorney Dannie Garrett to give advice to the Jury for operations of the Detention Center and craft an intergovernmental agreement.

Motion by Mrs. Vosburg and seconded by Mr. Pourciau:

RESOLVED, That Police Jury engages the services of Attorney Dannie Garrett to give advice to the Jury for operations of the Detention Center and craft an intergovernmental agreement.

#### PERSONNEL COMMITTEE

Chairman Cox reported on the Personnel Committee meeting held July 5, 2012. Copies of the minutes were given to each Juror for their review.

Chairman Cox informed the Jury that the Annual Employee Appraisal forms have been completed for each employee.

Motion by Mr. Cox and seconded by Mr. Jarreau:

RESOLVED, That a position vacancy announcement be posted for one (1) week for the position of Assistant Public Works Director, at an annual salary of \$39,207.00 (Pay Grade 214, minimum pay wage), depending upon experience; and be it

RESOLVED further, That if no response is received from employees, that a Position Notice for an Assistant Public Works Director be published in the official journal for two (2) weeks.

RESOLVED further, That the Organizational Chart in the Police Jury Personnel Policy Manual be amended to include the Animal Control Officer under the Parish Administrator.

Juror Young reported that Mrs. Lionel Signater of Callegan Lane at Morganza expressed her thanks and appreciation to the employees for the outstanding drainage work they performed on her property.

Juror Jarreau commended PA Bello and staff for an outstanding job they performed in organizing the quarterly safety meeting he attended for employees last month at the Civic Center.
