PUBLIC HEARING--FY 2018-2019 LCDBG PROGRAM

A hearing to obtain public input from citizens to obtain views on the housing and community development needs of the parish and to discuss the submission of an application for funding through the State of Louisiana FY 2018-2019 Community Development Block Grant (LCDBG) Program was held Tuesday, April 25, 2017 at 5:37 p.m. by the Police Jury of the Parish of Pointe Coupee, Louisiana at the Police Jury Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana.

Engineer Kevin Gravois explained the program and the process for submitting a grant application by the parish to obtain available funds for various projects of low and moderate income areas in the parish. He reported on the funds available and the Jury has to make a choice on whether to submit an application to obtain funds for water, sewer and street improvements. The Jury discussed funding sewer improvements in Sewerage Districts No. 1 or 3A in the parish, located in the districts of Jurors Dukes and Hurst. Engineer Gravois stated the sewer districts would be responsible for funding the administration and engineering fees. After discussion, Engineer Gravois will review this matter further with both sewerage districts and Jurors Dukes and Hurst so the Jury may select a project at their next meeting.

After receiving comments by Jurors and persons in the audience about the community development needs of the parish and the submission of an application for the FY 2018-2019 LA Community Development Block Grant Program, there were no objections received, orally nor written and the public hearing was closed.

## DISCUSSION AND CONSIDERATION OF HIRING AN ADMINISTRATOR & ENGINEER FOR FY 2018-2019 LCDBG PROGRAM

The Jury tabled discussion and consideration of hiring an administrator & engineer for the FY 2018-2019 LCDBG Program.

#### BBI ARCHITECTURAL FIRM PRESENTATION

Vice President Scot Byrd, along with President Brent Bueche, Project Manager Don Dauzat and Intern Architect Leonard Washington, gave a presentation from BBI Architects to provide architectural services to the Police Jury. He also presented a proposal to perform an ADA compliance survey of the Detention Center for the reroofing project.

Treasurer Becky Mayeux gave an overview of the services provided by Architect Carroll Blewster of Bradley-Blewster & Associates in submitting an application with USDA Rural Development for the Jury to fund the reroofing projects on the Courthouse, Courthouse Annex and Detention Center buildings. She reported on their cost estimate submitted to perform an ADA compliance survey of the Detention Center that is needed for the Jury's application with Rural Development to fund the reroofing project.

Motion by Mr. Dukes and seconded by Mr. Olinde:

RESOLVED, That Bradley-Blewster & Associates be authorized to complete an ADA compliance survey form for USDA Rural Development to reroof the Detention Center at a cost in the amount of \$800.00.
