The Pointe Coupee Parish Police Jury met in regular session at 5:30 p.m. Tuesday, August 8, 2017, at the Courthouse Annex in the Police Jury Meeting Room, New Roads, Louisiana.

President Melanie Bueche asked that the following persons, who passed away, be remembered in prayer:

President Melanie Bueche called the meeting to order and directed Secretary Gerrie Martin to call the roll:

UPDATE FROM WASTE CONNECTIONS

Mr. Joey Reppond of Waste Connections announced the merger with Republic Services for the collection of solid waste in the parish that will occur on September 1, 2017. He introduced Manager of Business Development & Municipal Services Karla Swacker and General Manager Sharon Mann of Republic who gave brief comments about their company and offered assistance to the Jury. After responding to questions from Jurors, Mr. Reppond requested approval of an acknowledgement letter from Waste Connections regarding the merger.

Motion by Mr. Cline and seconded by Mr. Cox:

RESOLVED, That Mrs. Melanie L. Bueche be authorized to sign an acknowledgement letter confirming the merger of Waste Connections with Republic Services for the collection of solid waste in the parish.

President Bueche gave an update on False River and reported the water level is 15.9 ft., and all gates are closed.

APPROVAL TO PLACE SPEED BUMPS ON ST. JOSEPH STREET AT NEW ROADS

Juror Dukes reported on a signed petition of over 50% of the residents requesting speed bumps be placed on St. Joseph Street at New Roads.

Juror Bazile, who represent a portion of the residents on said street, stated the residents are requesting the speed bumps.

Juror Cox commented on the disadvantages of placing speed bumps on roads in the parish that

causes damage to vehicles and roads. He reported that the speeding should be enforced by the law enforcements and not speed bumps, and that he is not in favor of spending monies on speed bumps.

Juror Dukes stated the signatures and petition was obtained by the residents, and he is only responding to their concerns and request to bring this matter to the Jury for approval.

Motion by Mr. Dukes and seconded by Mr. Bazile.

RESOLVED, That upon the result of a signed petition, that speed bumps be placed on St. Joseph Street at New Roads.
