Pointe Coupee Tourism Director Jeanie Andre reported on the promotion of tourism and upcoming events that will be held in the parish.

Mrs. Andre introduced Louisiana Lieutenant Governor Billy Nungesser who reported on tourism in the State of Louisiana, and offered assistance in promoting tourism in the parish.

Mrs. Andre and Lt. Governor Nungesser requested support of the Jury in their request to the state to change the name of LA Highway 418 at Lettsworth to Buddy Guy Street or Road in honor of Mr. Guy, a legendary Blues Singer and native of Lettsworth and Pointe Coupee Parish.

Motion by Mr. Dukes and seconded by Mr. Langlois:
RESOLVED, That Mr. Buddy Guy is a legendary Blues Singer and native of Lettsworth and Pointe Coupee Parish; and be it

RESOLVED further, That the Pointe Coupee Parish Police Jury hereby support changing the name of Louisiana Highway 418 at Lettsworth to Buddy Guy Road: and be it

RESOLVED further, That a copy of this resolution be forwarded to Lieutenant Governor Billy Nungesser, State Senator Rick Ward and State Representative Major Thibaut to support this endeavor.

Mrs. Andre and Mayor Pro Temp Clarence Wells of the Village of Morganza reported on the proposed Morganza revitalization project. Mrs. Andre also requested consideration of the Jury to use the Morganza Gym to host town meetings and fundraiser projects to revitalize Morganza.

Mrs. Andre reported on the development of a Louisiana Blues Highway 61 trail.

## DISCUSSION \& CONSIDERATION OF DESIGNATING US BICYCLE ROUTE 90 IN POINTE COUPEE PARISH

The following resolution was presented to the Jury for approval:
Motion by Mr. Bazile and seconded by Mr. Langlois:
A resolution of the Pointe Coupee Parish Police Jury stating its support for the development of U. S. Bicycle Route 90 through Louisiana.

WHEREAS, bicycle tourism is a growing industry in North America, presently contributing approximately $\$ 47$ billion dollars a year nationally to the economics of communities that provide facilities for said tourism; and

WHEREAS, the American Association of State Highway and Transportation Officials (AASHTO) has designated a corridor running east - west through south-central Louisiana to be developed as United States Bicycle Route 90 (USBR 90); and

WHEREAS, Bike Baton Rouge (BikeBR), Bike Walk MS, Bike Texas and Adventure Cycling Association (ACA), with the cooperation of the Louisiana Department of Transportation and Development and other stakeholders, have proposed a specific route to be designated as USBR 90, a map of which is herein incorporated into this resolution by reference; and

WHEREAS, the proposed USBR 90 traverses through 11 parishes, including Pointe Coupee, and is expected to provide a benefit to local residents and businesses; and

WHEREAS, the Pointe Coupee Parish Police Jury has duly considered said proposed route, determined it to be a suitable route through the parish, and desire that the route be formally designated so that it can be appropriately mapped and signed, thereby promoting bicycle tourism in Louisiana: Therefore be it

RESOLVED, That the Pointe Coupee Parish Police Jury does hereby express our approval and support for the development of USBR 90 and request that the appropriate government officials take action to officially designate the route accordingly as soon as possible; and be it

RESOLVED further, That the Pointe Coupee Parish Police Jury support the posting and maintenance of signs for said bicycle route once said designation has been made.

## NOTICE OF ELECTION

Pursuant to the provisions of a resolution adopted by the Police Jury of Pointe Coupee Parish, State of Louisiana (the "Governing Authority"), acting as the governing authority for the Parish of Pointe Coupee, State of Louisiana (the "Parish"), on the $27^{\text {th }}$ day of March, 2018, NOTICE IS HEREBY GIVEN that an election will be held on TUESDAY, NOVEMBER 6, 2018, and that at said election there will be submitted to all registered voters in the Parish qualified and entitled to vote at said election under the Constitution and laws of the State of Louisiana and the Constitution and laws of the United States of America.

## SECTION 1. ELECTION FOR PARISH PRESIDENT

Said election for Parish President will be held PARISHWIDE, at each and every polling place and encompassing each and every precinct within the Parish of Pointe Coupee, which polls shall open at six o'clock (6:00) a.m. and close at eight o'clock (8:00) p.m., in accordance with Louisiana law, specifically but not limited to LRS 18:541. The Commissioners-in-Charge and Commissioners, respectively, shall be those persons designated in accordance with Louisiana law.

## SECTION 2. ELECTION FOR PARISH COUNCIL MEMBERS

Said election for members of the Parish Council will be held in each of the various districts, precincts and polling places attendant thereto, establishing the eight single member districts of the Pointe Coupee Parish Council, as described below, which polls shall open at six o'clock (6:00) a.m. and close at eight o'clock (8:00) p.m., in accordance with Louisiana law, specifically but not limited to LRS 18:541. The Commissioners-in-Charge and Commissioners, respectively, shall be those persons designated in accordance with Louisiana law.

## SECTION 3. DESCRIPTION OF PARISH COUNCIL DISTRICTS

The Pointe Coupee Parish Council District members shall be elected from the eight single member districts as described below using the precinct boundaries and enumeration legally in force as of the time of this election.

Precinct 6: That Part commencing at the Point of Beginning at the intersection of centerline of Gayden Rd. and the northern municipal boundaries of Morganza, thence southerly on Gayden Rd. to the intersection with the southern municipal boundary of Morganza, thence generally westerly, northerly, and easterly on the Morganza municipal boundaries to the intersection with the centerline of Gayden Rd. and the Point of Beginning.

Precinct 16B: That Part commencing at the Point of Beginning at the intersection of the St. Landry/Pointe Coupee Parish boundary and the Union Pacific Railroad tracks, thence southeasterly on the railroad tracks to the intersection with the northern municipal boundaries of Fordoche, thence generally westerly, southerly, and easterly along the Fordoche municipal boundaries to the intersection with the Union Pacific railroad tracks, thence southeasterly to the intersection with the centerline of westbound lanes of U.S. Hwy. 190, thence easterly on U.S. Hwy. 190 to the intersection with western municipal boundary of Livonia, thence generally southerly, easterly, and southerly along the Livonia municipal boundaries to the intersection with the midflow of Grosse Tete Bayou, thence southerly a short distance to the intersection with the powerline right of way, thence westerly to the intersection with State Hwy. 77, thence southerly on Hwy. 77 to the intersection with the centerline of State Hwy. 977, thence southeasterly on Hwy. 977 to the intersection with the centerline of Canezaro Rd., thence westerly to the intersection with the midflow of an unnamed drainage lateral, thence southerly on the drainage lateral to the intersection with the midflow of Maringouin Bayou, thence northwesterly on Bayou Maringouin to the intersection with the centerline of Gravois Lane, thence westerly to the intersection with the centerline of the Union Pacific railroad tracks, thence southeasterly to the Iberville/Pointe Coupee Parish boundary, thence westerly on the Pointe Coupee Parish boundary to the intersection with the St. Landry/Pointe Coupee Parish boundary, thence northerly on the Parish boundary to the intersection with the centerline of the Union Pacific railroad tracks and the Point of Beginning.

Main Street, New Roads, Louisiana, on TUESDAY, DECEMBER 11, 2018, at FIVE THIRTY O’CLOCK (5:30) P.M., and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the election. All registered voters of the Parish of Pointe Coupee are entitled to vote in said election and voting machines will be used.
