President Olinde reported on a Public Works Committee meeting held July 9, 2018. He presented the following recommendations/resolution for approval:

On a vote of 7-3-2, the motion carried.

The Jury clarified that any existing culverts that are impeding drainage will be addressed and replaced by the Jury at the property owner's expense of purchasing materials and the Jury providing the labor.

ANNOUNCE CANDIDACY FOR PARISH PRESIDENT

State Representative Major Thibaut announced his candidacy for Parish President and asked the Jurors for their support.

He updated the Jury about the 2018 funding and application submission dates for LGAP and Capital Outlay funds for various projects in the parish. He also informed the Jury about problems with citizens being bitten by bats in the parish.
