The Pointe Coupee Parish Council met in regular session at 5:30 p.m. Tuesday July 12, 2022, at the Courthouse Annex in the Parish Council Meeting Room, New Roads, Louisiana.

Motion by Mr. Bazile and seconded by Mr. Gaspard:

PARISH PRESIDENT'S REPORT

Parish President Major Thibaut presented the financial report of the monthly budget to actual comparison on the ad valorem property taxes, sales tax collections, gas collections, licenses & permits, state severance, and state & federal funds, that included total revenues received of \$8,986,690 and total expenditures of \$5,357,077 for the month of June; received second half of the ARPA funds in June; two new employees, one termination and one position available; 3% salary increase for employees implemented in July; rebidding replacement of A/C at the PC Parish Detention Center; announced meeting on July 13, 2022 with Pelican Waste to discuss concerns about solid waste collections in the parish, and invited councilmembers to attend; and updates on the bridge replacement projects on Chenal Bayou, Pecan Island and Discharge Bayou.

PUBLIC COMMENTS ON AGENDA ITEMS

The public comments were waived until the specific agenda items are being discussed.

DISCUSSION OF A PROPOSED ORDINANCE TO AMEND THE POINTE COUPEE PARISH CODE OF ORDINANCES, CREATING AND REESTABLISHING A SINGLE BOARD TO SERVE AS THE GOVERNING AUTHORITY FOR EACH OF THE FIRE PROTECTION DISTRICTS IN EXISTENCE AND IN THE FUTURE CREATED IN POINTE COUPEE PARISH, IN ACCORDANCE WITH LRS 40:1504, AND THEREAFTER, CONSIDERATION OF THE ADOPTION

Town of Livonia Mayor Rhett Pourciau commented on the proposed ordinance to amend the Pointe Coupee Parish Code of Ordinances, creating and reestablishing a single board to serve as the governing authority for each of the fire protections districts in existence and in the future created in Pointe Coupee Parish, in accordance with LRS 40:1504. He suggested addressing and resolving problems within a particular district, instead of reestablishing a single board for the fire districts because of problems with some of the districts.

Mr. Jason Amato, member of the St. James Parish Council & Fire Chief of Lutcher Volunteer Fire Department, gave detailed overview of changes and successful improvements made to create a single board for the fire districts in St. James Parish. In closing, he responded to questions from the council.

Attorney Henry Olinde, who assisted the Advisory Study Committee on Fire District Governance with review and additional amendments to the ordinance, commented on the proposed ordinance and the creation of a single board for the fire districts. He also, responded to questions from the council.

Councilman Jarreau voiced concerns and objections to creating a single board for the fire districts.

Deputy Fire Chief Phil Larimore of Fire Protection District No. 5 voiced concerns and objections to creating a single board for the fire districts.

Chairman Boudreaux commented on his support of creating a single board for the fire districts in the parish being beneficial to the parish.

Motion by Mr. Bergeron and seconded by Mr. Boudreaux:

Attorney Wendell Clark of SBA Communications commented on their support of the ordinance and suggested changes made by SBA.
