

**MINUTES  
POINTE COUPEE PARISH COUNCIL  
EXECUTIVE COMMITTEE MEETING  
March 28, 2023**

The Pointe Coupee Parish Council Executive Committee met in regular session at 5:30 p.m. Tuesday, March 28, 2023, at the Courthouse Annex 2 in the meeting room, New Roads, Louisiana.

APPROVE MINUTES OF FEBRUARY 28, 2023 MEETING

DISCUSSION OF SOLID WASTE COLLECTION AND CONTRACT

Parish President Major Thibaut discussed extending the solid waste collection and disposal contract with Pelican Waste & Debris for an additional four years. He informed the council that the City of New Roads will also be negotiating their contract with Pelican Waste. He reviewed the various options that include once or twice a week collection, and a proposed monthly fee increase from \$18.87 to \$21.50 or \$26.38 per customer, due to the rising cost of fuel. After further discussion, the council will take actions on this matter at their April 11, 2023 meeting.
