NOTICE OF INTRODUCTION OF ORDINANCE AND PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a proposed ordinance to amend the Pointe Coupee Parish Code of Ordinances, relative to the membership of the governing board of Waterworks District No. 1 of Pointe Coupee Parish, Louisiana, following its consolidation with False River Water Works Corporation and otherwise provide with respect thereto has been introduced before the Pointe Coupee Parish Council, and that a public hearing will be held relative thereto at about 5:45 p.m., Tuesday, July 25, 2023 at the Parish Council Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana, after which said ordinance may be considered for adoption. All interested persons are urged to attend.

Parish President Major Thibaut gave a brief overview of the funding and merger of Pointe Coupee Parish Waterworks District No. 1 and False River Water Works Corporation, effective August 2, 2023. He reported the council clerk will advertise in The Pointe Coupee Banner for interested persons to serve on the new five-member board of commissioners, who will be appointed by the council on July 25, 2023.
