<u>PROCLAMATION - HONORING JOHN BURRELL GARNER FOR CONTRIBUTION TO 1960'S CIVIL RIGHTS MOVEMENT</u>

Motion by Mr. Bazile and seconded by Mr. Bergeron:

PROCLAMATION Honoring John Burrell Garner

WHEREAS, in 1960, the late John Burrell Garner was a twenty-six-year old law student at Southern University fulfilling a lifelong dream of studying law; and

WHEREAS, on March 29, 1960, during his tenure as a law student at Southern University Law Center in Baton Rouge, Louisiana, Garner fearlessly joined a sit-in protest at Sitman's Drug Store in downtown Baton Rouge, advocating for racial equality; and

WHEREAS, his courageous stance led to his arrest and subsequent suspension from the Law School without due process of law; and

WHEREAS, the Pointe Coupee Parish Council honors the bravery and courage that John Burrell Garner displayed by participating in the sit-in to fight for the civil rights of African Americans in Pointe Coupee Parish, Louisiana and around the world.

NOW, THEREFORE, I, DUSTIN BOUDREAUX, Chairman of the Pointe Coupee Parish Council, by virtue of the authority vested in me by the Parish of Pointe Coupee and the State of Louisiana, do hereby proclaim and commend **JOHN BURRELL GARNER** for his contributions to the 1960's civil rights movement.

Parish President Major Thibaut gave updates and PowerPoint presentation on the following: Hired new equipment operator, and advertising for a staff accountant; finances including sales tax, ad valorem tax, severance tax, utilities collections and permits fees; total revenues of \$8,743,060 total expenditures of \$7,459,234 and total excess of revenue of \$1,283,826 as of June 30, 2023; capital outlay funding awarded to parish to finance various projects; public works projects, animal shelter at capacity; PC Rec have six all-star teams; update on improvements at Batchelor & False River Recreation Parks; master plan for False River Recreation Park and multi-use center; improvements at the detention center; roadside grass cutting; buoy replacements; fire alarm project at courthouse; complaints received about solid waste and bulky waste collections; permits issued in June; invited available councilmembers to attend a meeting on Thursday, July 12, 2023 at Alma Plantation; Nextera Energy hosting public meetings in Livonia July 24 & 25, 2023 regarding a proposed Mondu Solar Project; parish received first opioid settlement check from lawsuit; and update on merger of False River Water Works with PC Parish Waterworks District No. 1, and advertising for interested persons to serve as members of the new board. In closing, he responded to questions from council.

A hearing to obtain public input to a proposed ordinance to amend Chapter 22 of the Pointe Coupee Parish Code of Ordinances, relative to subdivisions in the parish, and further provide with respect thereto was conducted at 5:55 p.m., Tuesday, July 11, 2023 at the Parish Council Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana.

Mr. Marvin Losavio of 15944 Hwy. 417, Batchelor, Louisiana voiced concerns about the proposed amendments to the ordinance that require families dividing their properties to obtain approval from neighbors and parish, along with required fees.

President Boudreaux reported the amendments to the ordinance allows the parish administrator the authority to approve standard subdivisions of properties without approval from the Planning & Zoning Commission.
