## PROCLAMATION CATHOLIC SCHOOLS WEEK 2024

WHEREAS, Catholic schools across the nation are celebrating Catholic Schools Week from Sunday, January 28 through Saturday, February 3, 2024; and

WHEREAS, Catholic schools in the Diocese of Baton Rouge evangelize hearts, educate minds, encourage talent and embrace the future; and

### PARISH PRESIDENT'S REPORT

Parish President Major Thibaut gave updates in a PowerPoint presentation and written report on the following: finances including sales tax, ad valorem tax, severance tax, utilities collections and permits fees; total revenues of \$17,306,747, total expenditures of \$16,955,876 and excess of revenue of \$350,871 as of December 31, 2023; overview of finances for the past five years from 2019 budget of \$15.6 million dollars to 2024 budget of \$27.2 million dollars; drainage and infrastructure projects being funded by grants for 2024; economic development and moving the parish forward in 2024; and congratulated the councilmen on their re-elections.

#### PUBLIC COMMENTS ON AGENDA ITEMS

Messrs. Travis Saizan, Bob Allen, Randy Tassin and Travis Laurent waived their public comments until the agenda items are discussed.

PUBLIC HEARING ON AN INTRODUCED PROPOSED ORDINANCE TO ENACT CHAPTER 2, SECTION 2-9, OF THE POINTE COUPEE PARISH CODE OF ORDINANCES, PERTAINING TO SETTING SALARY OF PARISH PRESIDENT, AND THEREAFTER, DISCUSSION & CONSIDERATION OF THE ADOPTION

A hearing to obtain public input to a proposed ordinance to enact Chapter 2, Section 2-9, of the Pointe Coupee Parish Code of Ordinances, pertaining to setting salary of Parish President, and further provide with respect thereto was conducted at 5:46 p.m., Tuesday, January 9, 2024 at the Parish Council Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana.

Mr. Travis Saizan of 13979 Ventress Road, Ventress, Louisiana made comments about setting and increasing the salary of the Parish President and altering the Home Rule Charter for raises.

Councilman Jarreau reported the ordinance was out of compliance with the Home Rule Charter to set and increase the salary of the Parish President. He opposed the ordinance and increasing the salary of the president from \$131,888 to \$168,949, which is 86% of the base salary of the sheriff. He commented on the charter as it relates to setting the president's salary, and that the ordinance cannot supersede the charter, and any amendments to the charter would have to be done by an election and vote of the people. In closing, Chairman Jarreau asked the council for a resolution of support to his Attorney General's Opinion he submitted regarding the legality of increasing the salary of the Parish President.

Councilman LaCoste commented about the president not receiving the 3% annual salary increase the employees received since in office, and that his salary increase is in line with other parish presidents.

Attorney Dannie Garrett, who crafted the ordinance and assisted the commission with crafting the Home Rule Charter for the parish, gave a legal opinion and explanation of Section 3.03(A) and Section 3.03(C) of the Home Rule Charter that establish and increase the salary of the Parish President. He reported Section 3.03(A) sets the initial salary of the first president, and after the first term, Section 3.03(C) allows the council to approve the salary increase by ordinance.

Councilman Bergeron reported based upon the legal opinion and the duties of the parish president, the salary increase is deserving and should be considered.

In response to Councilman Jarreau, President Boudreaux and Attorney Garrett reported, per the charter, any increase in salaries of the councilmembers may be changed by ordinance and cannot become effective during the term in which it is adopted, and no such ordinance shall be adopted in the last year of term. Attorney Garrett also reported term limits are changed by an amendment to the charter, which is voted on by the citizens of the parish.

Chairman Boudreaux gave an overview of discussions and review for months and during budget hearings by the council about increasing the salary of the Parish President, and comparison with the base salary of the sheriff. He concluded that the salary increase is warranted and should reflect the nature of the job.

There were no objections received orally or written to the ordinance.

Motion by Mr. Bergeron and seconded by Mr. Bazile:

RESOLVED, That the proposed ordinance to enact Chapter 2, Section 2-9, of the Pointe Coupee Parish Code of Ordinances, pertaining to setting salary of the Parish President, and otherwise provide with respect thereto be adopted by the Pointe Coupee Parish Council.

Mr. Travis Saizan made comments about if the fire districts funded the E-911 system, and suggested asking for additional taxes for the system.

In response to Mr. Saizan's comments, Chairman Boudreaux reported discussion of a sales tax by the sheriff to fund E-911 has been postponed until the results of the tax study.

Vice Chairman Bob Allen of PC Fire Districts Board of Commissioners appeared before the council to support the approval of the resolutions to hold an election to levy a special property tax in Fire Districts No. 2, 3 & 5 to increase their revenues and fire service to the public.

Chairman Boudreaux reported on encouraging the three fire districts to consider holding their elections for a special property tax after the results of the tax study, in an effort that the data from the study would be beneficial to the citizens to support any request for additional taxes.

Chief Aaron Edwards of PC Parish Fire Protection District No. 2 gave a brief overview of the request and need to hold an election in the district to levy a special property tax of 15 mills to generate additional revenues. After responding to questions from councilmembers and discussion, the following resolution was offered:
