RESOLVED, That the low base bid in the amount of \$2,565,000.00 submitted by Omega Foundation Services, Inc. for the False River Ecosystem Restoration - Phase IV Retaining Wall Replacement Discharge Bayou and Lighthouse Canal Project, Louisiana Facility Planning Project No. 50-J39-12-01, be accepted by the Pointe Coupee Parish Council, and the contract to be awarded pending concurrence of Facility Planning and Control and the Pointe Coupee Parish Government commitment to fund the project until completion; and be it

RESOLVED further, That Parish President Major Thibaut, on behalf of the Pointe Coupee Parish Government, be authorized to sign the contract agreement and all necessary documents for said project.
