#### FREE ROAMING CATTLE ON PUBLIC ROADWAY

Juror Monk reported on free roaming cattle on a public roadway that resulted in damages to the property of Brad & Trudy Lewis at their camp off of Charles Hopkins Road in Juror District 1. This matter has become a civil matter and will be awaiting a legal response, thereafter, will decide what legal actions the Jury may take in the future. Mr. Lewis commented on this matter.

#### DISCUSSION OF A FINANCIAL PROPOSAL

President Bueche read a prepared statement and presented a financial proposal to introduce a monthly drainage impact fee of \$5.00 per household to the residents in the parish for the Jury's consideration and to increase their revenues. This fee would be imposed by conducting a public hearing and adoption of an ordinance.

Jurors commended President Bueche for her proposal. Jurors made comments and voiced concerns about the proposal and presented alternative ideas and suggestions to increase their revenues.

Juror Young commented on the Personnel Committee meeting held yesterday and the discussions of ideas to increase their revenues.

Juror Jarreau stated that it is not fair to ask the low to moderate income residents to pay the same fee as residents who are in a higher income bracket, who could afford to pay the fee, and he could not support asking everyone to pay the same fee.

### DISCUSSION OF AN ORDINANCE FOR UNLAWFUL USE OF A WEAPON IN THE PARISH

Juror A. Dukes discussed and asked the Jury to consider crafting an ordinance for unlawful use of a weapon in the parish. He reported on an incident where he was awaken by gun shots near his residence. After discussions, Parish Administrator Bello was asked to research ordinances from other parishes to assist with crafting an ordinance for the Jury.

## <u>APPROVAL OF AN APPRAISAL FEE FOR PROPERTY OFF OF HOSPITAL ROAD OWNED BY MARC BARKER</u>

Juror Olinde requested approval of an appraisal fee for property off of Hospital Road owned by Marc Barker.

Motion by Mr. Olinde and seconded by Mr. C. Dukes:

RESOLVED, That the proposal submitted by The Lakvold Group, LLC in the amount of \$2,750.00 to provide an appraisal of property at 1919 Hospital Road & 2001 Hospital Road at New Roads owned by Mr. Marc Barker be accepted.
