RESOLUTION – AWARD LOW BID FOR WATERSHED DRAINAGE IMPROVEMENT PROJECT PHASE 2 TO CHEM SPRAY SOUTH INC. & AUTHORIZE PARISH PRESIDENT TO SIGN CONTRACT

**RESOLVED**, That the low base bid in the amount of **Six Hundred Twenty Thousand Dollars (\$620,000.000)**, together with Alternate No. 1 in the amount of **Two Hundred Thousand Dollars (\$200,000.00)** and Alternate No. 2 in the amount of **One Hundred Ninety-Six Million Sixteen Thousand Two Hundred Fifty Dollars (\$196,250.00)**, for a total contract amount of **One Million Sixteen Thousand Two Hundred Fifty Dollars (\$1,016,250.00)**, submitted by Chem Spray South, Inc. for the *Watershed Drainage Improvements Project – Phase 2* (Facility Planning & Control Project No. 50-J39-22-03), be and is hereby accepted by the Pointe Coupee Parish Council, and that the contract be awarded accordingly; and

**BE IT FURTHER RESOLVED**, That Parish President Major Thibaut, on behalf of the Pointe Coupee Parish Government, be and is hereby authorized to execute the contract agreement and all necessary documents for said project.
