A hearing to obtain public input to condemn and demolish an abandoned house owned bythe Virginia Hargrove Estate located on Lot 36 in J. V. Loupe Subdivision at New Roads was conducted at 5:16 p.m. on Tuesday, August 11, 2015 at the Police Jury Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana.

CONSIDERATION TO SCHEDULE A PUBLIC HEARING FOR LA COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FY 2016-2017 APPLICATION

Engineer Kevin Gravois of PEC requested approval of the Jury to consider scheduling a public hearing at their next meeting to obtain comments about the submittal of a LA Community Development Block Grant Program FY 2016-2017 application to perform a particular project in low and moderate areas of the parish. He reported the Jury would obtain public comments at the hearing and make a determination of the type of project they want to fund such as water, sewer or roads.

Juror A. Dukes requested an update on the salary adjustments for 10 employees at the Pointe Coupee Communications District E-911 and the fire districts allocating funds to support the adjustments.

WHEREAS, Pointe Coupee Parish has the benefit of a direct dispatch 911 system; and

WHEREAS, the direct dispatch 911 system makes it much more efficient in dispatching fire, health, and law enforcement personnel to the people of Pointe Coupee facing emergencies; and

WHEREAS, the Sheriff's Office operates the Pointe Coupee Parish 911 System under a Cooperative Endeavor Agreement with the Police Jury, hospital, municipalities and fire districts in Pointe Coupee Parish; and

WHEREAS, the personnel assigned to operate the 911 system are valued employees and are deserving of more compensation than the current budget can provide; and

WHEREAS, some of the Fire Districts in the Parish have agreed to contribute additional funds to support a salary supplement to the 911 personnel; and

WHEREAS, there is still an additional need for funding for salary supplements for those 911 personnel.

NOW, THEREFORE, BE IT RESOLVED, That the Pointe Coupee Parish Police Jury hereby urges the other Fire Districts that are not currently contributing to the salary supplement for the 911 personnel to agree to begin contributing to the salary supplement; and

BE IT FURTHER RESOLVED, That a copy of this resolution be forwarded to each of the Fire Districts that are not currently contributing to the salary supplement for the 911 personnel.

The motion died, due to lack of a second.

<u>DISCUSSION & CONSIDERATION OF PROPOSAL TO UPDATE THE ROAD RATING</u> REPORT

Engineer Kevin Gravois presented a proposal for consideration to update the 2010 Road Rating Report, due to the Police Jury investigating the possible sale of bonds for a road program. The purpose of the report is to determine the current needs and construction cost in the parish.

Motion by Mr. Jarreau and seconded by Mr. Cline:

RESOLVED, That the proposal submitted by Professional Engineering Consultants Corporation to update the 2010 Parish Road Rating Report in the amount of \$21,000 be accepted.

RESOLVED, That Mrs. Melanie L. Bueche be authorized to execute an Intergovernmental Cooperative Endeavor Agreement between the Pointe Coupee Parish Police Jury and LA Department of Transportation and Development (DOTD) for the Jury to receive reclaimed corrugated metal pipe from DOTD to be utilized for the Amalie Acres Drainage Project off of LA Hwy. 978 at Oscar.

SELECTION CRITERIA

Chairman Cox reported on a Selection Criteria Committee meeting held August 4, 2015. Copies of the minutes were emailed to each Juror.

Motion by Mr. Cox and seconded by Mr. Jarreau:

RESOLVED, That the Home Rule Charter Commission consist of not more than three (3) Jurors and eight (8) lay people selected by the full Police Jury with the understanding the Jurors elected forfeit their right to appoint a lay person (contingent to President Melanie Bueche not submitting a person in her district).

RESOLVED, That to be considered for appointment as a commissioner an applicant must be a qualified elector of the parish.

Unanimously carried.

Motion by Mr. Cox and seconded by Mr. Olinde:

RESOLVED, That the last date for submission of applications be Friday, September 11, 2015 at 12:00 p.m.; and be it

RESOLVED further, That the Selection Criteria Committee conduct a vetting meeting of the applicants Tuesday, September 15, 2015 at 5:30 p.m. and bring recommendations to the Police Jury meeting September 22, 2015.

RESOLVED, That the Police Jury budget be amended for \$5,000 to be allocated to the Home Rule Charter Commission for expenses.

RESOLVED, That a Home Rule Charter Commission's secretary be a Police Jury staff secretary and be compensated from the budgeted funds, pending the same rule applies for all committees created by the Police Jury.

Motion by Mr. C. Dukes and seconded by Mr. Olinde:

RESOLVED, That the Police Jury amend the timeline provision in the resolution adopted at the July 28, 2015 meeting for the Charter Commission to be appointed from within thirty (30) days to ninety (90) days.

Unanimously carried.

Chairman Cox asked the Jury to consider placing an ad in The Banner to explain and educate the public on the process of the Charter Commission and the parish form of government. After discussion, Attorney Garrett will prepare information and forward to Jurors to be considered for publication and make available to the public.
