### ANNUAL REPORT ON VETERANS AFFAIRS IN POINTE COUPEE PARISH

Mrs. Tammy Delatte of the Louisiana Department of Veterans Affairs gave the annual report on Veterans Affairs in Pointe Coupee Parish. She reported they provided compensation and pension of \$5,026,000.00 to 1,711 veterans and their families in the parish in 2014.

# INTRODUCTION OF AN ORDINANCE TO MERGE PRECINCTS WITH LESS THAN 300 ACTIVE REGISTERED VOTERS IDENTIFIED BY THE SECRETARY OF STATE'S OFFICE

Mr. Mike Hefner of Geographic Planning & Demographic Services, LLC presented and reviewed an introduction of a proposed ordinance to merge precincts 8B & 21with less than 300 active registered voters that have been identified by the Secretary of State's Office. He reported the mergers will become effective in 2016.

Motion by Mrs. Vosburg and seconded by Mr. Pourciau:

NOTICE IS HEREBY GIVEN that an ordinance to amend Chapter 2 of the Code of Ordinances of the Parish of Pointe Coupee, Louisiana relative to the merger of voting precinctshas been introduced before the Police Jury of the Parish of Pointe Coupee, Louisiana, and that a public hearing will be held relative thereto at 5:00 p.m., Tuesday, October 13, 2015 at the Police Jury Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana, after which said ordinance may be considered for adoption. All interested persons are urged to attend.

### CONSIDERATION & ADOPTION OF A REDUCTION OF MILLAGE RATE(S)

President Bueche read correspondence from Attorney Dannie Garrett stating September 11, 2015, the Louisiana Supreme Court denied the Application for Writ of Certiorari filed by the Jury. The impact is that the 3-2 ruling of the First Circuit Court of Appeal became final September 19, 2015. The ruling also granted an injunction against the Police Jury from raising the millage rate from 1.71 to 3.42. As a result of this ruling, Attorney Garrett recommended the Jury consider revising and lower the millage rate for property within New Roads from 3.42 to 1.71.

President Bueche recognized Parish Assessor James "Jimmy" Laurent, Jr. to address any questions or concerns about the adoption of the amended millage rates(s) for 2015.

Motion by Mrs. Vosburg and seconded by Mr. Jarreau:

BE IT RESOLVED, That the following millage(s) are hereby amended and levied on the 2015 tax roll on all property subject to taxation by the Police Jury of the Parish of Pointe Coupee, Louisiana:

### **MILLAGE**

Parish Tax in City of New Roads

1.71 mills

BE IT FURTHER RESOLVED, that the proper administrative officials of the Parish of Pointe Coupee, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2015, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.

The foregoing resolution was read in full, the roll was called on the adoption thereof, and the resolution was adopted by the following votes:

## <u>CONSIDER ENTERING INTO AN AGREEMENT FOR ELECTRONIC MONITORING</u> WITH AEMLA, LLC FOR INMATES

President Bueche discussed the Jury's consideration of entering into an agreement for electronic monitoring with AEMLA, LLC for inmates, instead of inmates being incarcerated.

Juror Cox gave an overview and his support of the electronic monitoring program.

Motion by Mr. Cox and seconded by Mr. A. Dukes:

RESOLVED, That Assistant District Attorney John Wayne Jewell be authorized to review and make appropriate changes to an agreement between the Jury and AEMLA, LLC for electronic monitoring of inmates to be reviewed by the Detention Center Committee.

# APPROVAL OF A RENTAL AGREEMENT FOR USE OF THE MORGANZA GYM BY PARISH SCHOOLS

Juror Vosburg requested the Jury's approval of a rental agreement for use of the Morganza Gym by parish schools.

Juror Vosburg discussed using the Morganza Gym for various events and activities in the parish such as youth sports programs that would include clinics, demonstrations and techniques, and a fitness program for senior citizens.

# REQUEST UPDATE FROM DA RICKY WARD ON MAYOR ROBERT MYER'S INVESTIGATION

Juror A. Dukes reported DA Ricky Ward does not have the investigation report of Mayor Robert Myer. He informed the Jury he will be asking Secretary Martin to send a letter to Mr. Greg Phares of the Office of State Inspector General requesting that he be notified when this case is given to the DA's Office. He stated that his constituents are asking him about this matter and he would like to be kept informed.

#### GEO TRACKING FOR OFF ROAD GRASS CREW AND TRUCK

Juror Cox reported on concerns he and Juror Olinde have about lack of supervision in the field and consideration of placing GEO tracking for off road grass crew and truck. Juror Cox gave an overview of the operations of the GEO Tracking, the benefits and cost savings to the parish.

Motion by Mr. Cox and seconded by Mr. Olinde:

RESOLVED, That the Parish Administrator be authorized to obtain a parish inventory list of all vehicles to be presented to Juror Justin Cox and discussed at the next Finance Committee meeting for consideration of the GEO Tracking on vehicles.

Treasurer Becky Mayeux reported that she has a 10:00 a.m. webinar tomorrow with AT&T to discuss and obtain a demonstration of the operations of the GEO Tracking, and will receive two (2) demos for the Jury to try for three (3) days.

# ANNUAL CERTIFICATION OF COMPLIANCE WITH OFF-SYSTEM BRIDGE REPLACEMENT PROGRAM

Motion by Mrs. Vosburg and seconded by Mr. Cox:

## ANNUAL CERTIFICATION OF COMPLIANCE WITH STATE OF LOUISIANA OFF-SYSTEM BRIDGE REPLACEMENT PROGRAM

WHEREAS, the Code of Federal Regulations as enacted by the United States Congress mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity and posted in accordance with the National Bridge Inspection Standards and that an inventory of these bridges be maintained by each State; and

WHEREAS, the responsibility to inspect, rate and load post those bridges under the authority of Pointe Coupee Parish in accordance with those Standards as delegated by the Louisiana Department of Transportation and Development to Pointe Coupee Parish: Therefore be it

RESOLVED, That the governing authority of Pointe Coupee Parish (herein referred to as the Parish) that the Parish in regular meeting assembled does hereby certify to the Louisiana Department of Transportation and Development (herein referred to as the DOTD) that for the period 1 October 2015 through 30 September 2016:

- 1. The Parish has performed all interim inspections on all parish owned or maintained bridges in accordance with the National Bridge Inspection Standards.
- 2. All bridges owned or maintained by the Parish have been structurally analyzed and rated by the Parish as to the safe load capacity in accordance with AASHTO Manual for Maintenance Inspection of Bridges. The load posting information that has been determined by the LA DOTD for all bridges where the maximum legal load under the operating rating as determined above has been critically reviewed by the Parish. Load posting information has been updated by the Parish to reflect all structural ratings.
- 3. All Parish owned or maintained bridges which required load posting or closing are load posted or closed in accordance with the table in the DOTD Engineering Directives and Standards Manual Directive No. 1.1.1.8. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting.
- 4. All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Correction to data supplies to the Parish by the LA DOTD are noted.

These stipulations are prerequisites to participation by the Parish in the Off-System Bridge Replacement Program.
