# PUBLIC HEARING--TO AMEND ARTICLE III, SECTION 8-31B OF THE CODE OF ORDINANCES TO REMOVE THE SUNSET CLAUSE FROM THE DRAINAGE MAINTENANCE FEE

A hearing to obtain public input to a proposed ordinance to amend Article III, Section 8-31B of the Code of Ordinances to remove the sunset clause from the Drainage Maintenance Fee was held Tuesday, March 22, 2016 at 5:45 p.m. by the Police Jury of the Parish of Pointe Coupee, Louisiana.

Mr. Lawrence Smith inquired about the purpose of Drainage Maintenance Fee. President Dukes stated the fee is to help supplement drainage expense throughout the Parish. Juror Melanie Bueche stated the ordinance for the fee is to offset the short fall in the drainage fund. Juror Stephen Smith stated the purpose of the Public Hearing is for removing the sunset clause. Juror Anthony Hurst expressed concern of customers that do not have utilities bills the fee can be to attach to monthly, receiving once a year bills for the full amount.

Mrs. Gail Hurst stated she was in not favor of the removal of the sunset clause because she believes the Jury should be responsible for spending and serve the citizens legally and honestly.

Mr. Roosevelt Gremillion stated he was not in favor of the removal of the sunset clause and the Jury should act upon this matter in which the ordinance was intended.

Mr. Marvin Lasavio stated he was against the removal of the sunset clause and spoke of an issue in the district in which he lives and that the drainage program should be fair to everyone.

Mr. Greg Johnson stated the Drainage Maintenance Fee is hard to support if there is no action from the Jury.

Juror Olinde stated it was not easy for the Jury to approve an ordinance that put charges on every household. He further stated without the fee (DMF) the Jury would lose equipment, need to lay off employees and is needed to keep the organization funded.

Mr. Anthony Daisy stated the DMF was imposed without getting feedback from the citizens. He further stated having Iberville Parish also keep up with the drainage in Portage Canal.

Reverend Margie Thomas stated she was against the DMF because years ago culverts were to be installed and ditches were to be closed.

Juror Bueche stated the DMF is not a tax, it is a legal fee and public hearings were held before the ordinance was passed. She further stated closing ditches restrict the flow of water and cause flooding and that keeping drainage open helps with flooding issues.

The Public Hearing closed at 6:17 p.m.

DISCUSSION & CONSIDERATION TO AMEND ARTICLE III, SECTION 8-31B OF THE CODE OF ORDINANCES TO REMOVE THE SUNSET CLAUSE FROM THE DRAINAGE MAINTENANCE FEE

Juror Cox explained after giving thought to things that are needed to be done within the Parish and reviewing the budget that reflects the calendar year end of December 31, he cannot support the removal of the sunset clause for the DMF. He stated the Jury is awaiting information on the efficiency study from Springsted, Inc. and is in need of a parish administrator with a degree in accounting/finance. By giving the parish administrator the opportunity to review the Parish's finances and bring the findings to the citizens they can chose if the DMF is necessary. He further stated by doing this the Parish will have to cut some services and will have to make a reduction in employment. The Parish will have to cut other services in a manner in which does not cut out the service all together.

Juror Smith stated at his personal work he campaigns for drainage projects. He stated the citizens do want to see progress. He further stated he is not against DMF but, cannot support it at this time. He would like to revisit this issue in the future.

Juror Hurst apologized for being a juror for three (3) months and is in a learning process. He stated he understands the concerns and explains the drainage service is based on funds received. He also stated the drainage program should be based on priority. He further stated he is not for a reduction in employment because working families bring tax dollars to the Parish.

Juror Jarreau stated since 2008 the parish has been spending more than what is being received. He stated with funding issues, how does the Parish get back on track. Once the efficiency study is reviewed this will help with finding ways to close the gap. Treasurer Mayeux responded to Juror Jarreau stating that culverts are funded through the Drainage Fund account. Juror Jarreau stated he wants to review all information before making his decision on the DMF.

Juror Mitch Langlois stated he is in favor of the removal of the sunset clause.

Juror Taylor stated the Parish has six (6) new jurors that have inherited the issues of the past.

Juror Bueche stated the Jury did not keep the LRA-DR funds, instead they here distributed to the School Board for hardening and generators and to the sewer systems for generators.

After further discussion the following resolution was offered:

RESOLVED, That the sunset clause for the Drainage Maintenance Fee of June 30, 2016 not be removed but, extended to December 31, 2016.

# UPDATE AND INFORMATION PERTAINING TO LEGISLATIVE SESSION

Senator Rick Ward and Representative Major Thibaut explained the special session called for decisions regarding the cuts made for the short fall, tax credits and taxes. Current budget has a \$70 million shortfall.

Senator Ward stated decisions were made by setting forward the vital services. He encouraged a continued relationship with Jury and audience and asked that he be contacted for concerns.

Representative Thibaut stated LGAP funding is still intact and the Jury should get most of the requested projects funded.

Representative Thibaut recommended the Jury focus on 3-4 prioritized projects for Capital Outlay for the next four (4) years.

The Senator and Representative took questions from the Jurors and audience.

In response to Juror Gordon Taylor he was informed the TOPS program will see a cap put on it.

In response to Editor Tommy Comeaux he was informed the status of the Waiver Program for disabled children and families has stayed in tack.

In response to Juror Smith he was told that feedback is important in Balancing the Budget.

In response to Mrs. Gail Hurst she was informed of a meeting with the governor, but no information was given in regards to the state credit rating.

In response to Rev. Thompson she was told funds distributed from casinos should be equal to video poker but, it is not in the call but, not ruled out for the next special session.

In response to Juror Taylor he was informed the revenue from steel is handled by the Congressional delegation.

In closing Chairman Dukes thanked Senator Ward and Representative Thibaut for their time and answering all the concerns.

Senator Ward stated it is vital to be on the same page and asked that for any concerns that you contact his office and he looks forward to continuing working with everyone for the next four (4) years.

# POINTE COUPEE SCHOOL TAX PROPOSITION

Pointe Coupee School Board Superintendent Kevin Lemoine reviewed a power point presentation of the proposed millage proposal for 2016 with the Jury. He explained the proposal began with the teachers wanting a pay increase, so a six (6) month study was conducted and the teachers asked the proposal be submitted to be placed on the ballot this fall.

The proposition is for a 10 mill, 10 year property tax with an estimation of \$4,500,000 per year. He stated 7.1 mills will be for salary increases for non-contract employees, and the remaining estimated 2.9 mills will be dedicated to infrastructure improvements and fund balance stabilization. The teachers will receive a \$5,000 pay raise and other support personnel will receive a \$2,250 pay raise.

Juror Cox stated he supports the public school system and it is important to have qualified teachers and to keep them in the Parish.

Juror Smith stated as chairman of the Economic Development Committee the committee will be gathering information on education.

Juror Watkins offered his support by cooking a jambalaya.

Juror Hurst thanked the teachers for what they do and inquired if the teachers were actually going to receive the money. He also stated rumors that he had heard.

Juror Jarreau stated Superintendent Lemoine is doing a wonderful job and that he respects and supports the teacher's proposition.

Juror Taylor stated he would support the proposition if he knew Superintendent Lemoine's plans for the future. Superintendent Lemoine stated he is all about accountability and there was a flyer in last week's Banner and information on the website that can be reviewed.

Juror Bazile stated he wants things turned around.

#### <u>UPDATE ON USDA LOAN APPLICATION FOR ROOF REPAIRS</u>

Messrs. Charles Miniex and Rick Hullin from USDA Rural Development introduced themselves and presented handouts regarding business and personal loans.

Mr. Hullin explained the Jury has applied for a loan for roof repairs to the Detention Center, Courthouse and Annex Building. He stated he contacted Treasurer Mayeux this week to advertise filing of the loan in the official journal which will be published this Thursday. He stated once it published and a publication affidavit is provided, then a Preliminary Architectural Feasibility Report will be need from the architect. The loan will be reviewed by the underwriter and the terms will be determined.

Juror Bueche left the meeting at 8:05 p.m. and Jurors Cox and Jarreau left the meeting at 8:19 p.m.

# SECURE AN ARCHITECT FOR THE USDA LOAN FOR ROOF REPAIRS/REPLACEMENT OF THE DETENTION CENTER, COURTHOUSE AND ANNEX BUILDING

After hearing the loan application process that was presented by USDA and a good reference from Floodplain Administrator Cletus Langlois on the work performance of Bradley-Biewster & Associates the following resolution was offered:

WHEREAS, the greater recognition and understanding of autism can ensure that individuals with autism are accurately diagnosed and appropriately treated throughout their lives.
