# <u>PUBLIC HEARING--LEVYING INCREASED MILLAGE RATES AND ROLLING FORWARD MILLAGE RATES</u>

A hearing to obtain public input from citizens to consider levying increased millage rates after reassessment and rolling forward millage rates not exceeding the maximum authorized by law was conducted at 5:30 p.m., Tuesday, September 13, 2016 at the Police Jury Meeting Room, Courthouse Annex, 160 East Main Street, New Roads, Louisiana.

President Dukes introduced Parish Assessor James Laurent, Jr. who appeared to address any questions or provide information about the millage rates in the parish.

There were no objections received from persons in the audience and the public hearing was closed.

President Cornell Dukes called the meeting to order and directed Secretary Gerrie Martin to call the roll:

members present.

Juror Cox urged Jurors not to attend the convention due to budget constraints.

#### UPDATE ON LA DEPARTMENT OF VETERANS AFFAIRS

Mrs. Tammy Delatte of the Louisiana Department of Veterans Affairs gave the annual report on Veterans Affairs in Pointe Coupee Parish. She reported they provided compensation and pension of \$5,767,000 to 1,679 veterans and their families in the parish in 2015.

#### **LAND SURVEYOR REPORT**

Land Surveyor Cletus Langlois gave an update on the drainage in Pecan Acres Subdivision at New Roads and reported on plans to raise the levee over 28 ft. in areas that have deficiencies in the subdivision. He gave an update on the various programs and financial assistance available to the residents in the subdivision as a result of the flood. He reported FEMA

has ordered an environmental study of the subdivision before the drainage project will commence approximately January 2017.

Mr. Langlois addressed questions and comments from Jurors.

Public comments were made by the following persons concerning the recent flooding:

Mrs. Karla Jack, spoke person for the residents of Pecan Acres Subdivision, read a prepared statement and presented a list of questions and request to be answered and addressed by the Jury.

In response to Mrs. Jack, Juror Cox read minutes from a Jury meeting of October 27, 1998 that revealed the scope of the Pecan Acres Drainage Project was changed at the request of the citizens and City of New Roads that resulted in lowering the levee in Pecan Acres by the Jury. He commented on moving forward to resolving the flooding problems in Pecan Acres and to not continue dwelling on what has happen in the past, and as a Jury to assist with seeking the necessary funding and provide solutions to this matter.

Juror Smith stated Mr. Langlois works very hard and his efforts are very sincere, and that he does everything for the benefit of everyone involved.

Juror Watkins commented on the new Jurors should not be held liable for what happened in the past, since they have only been in office for nine months and found the current flooding problems. He stated they are willing to assist in resolving the flooding problems.

Mr. Lawrence Smith commented on the negative affect the drainage project will have on the resident on the south side of Bayou Pond and Pleasant View Subdivision. He commented the shelter in place program will cause an increase in the residents utilities bills because there will be no walls and insulation in their homes.

Mrs. Rita Jones commented something needs to be done to eliminate the rats, spiders and snake that have increased due to the flooding.

Ms. Michelle Farris commented she may not get a renewal for her flood insurance because this will be the second time she has filed a claim on her home flooding.

President Dukes made closing remarks and reported he received instructions from GOSHEP and FEMA after their last community meeting to obtain names and addresses of homeowners affected by the flooding so they could be contacted and address any needs they may have, but has not received the list to give them. He stated in order for the Jury to assist residents and direct them to the proper agencies, they need to know what the needs are from the residents. He stated his goal when attending the community meetings are to bring people together so they could possibly obtain the necessary benefits from FEMA and GOSHEP they need to move forward.

In closing, the Jury agreed to setup another community meeting where the various agencies, state officials and experts will be in attendance to address all the needs of the residents affected by the flood.

Juror Cox stated he is of the opinion there is a lot of hurting, emotional and people with medical conditions dealing with the recent flooding. He stated when people in the community is being divided because they think the Jury is not providing certain information, the public needs to know that it's not the Jury but, a certain person who has the information that has not been presented to the Jury that could assist in providing help to the people in need.

Mrs. Gail Hurst confirmed that she personally obtained and gave the documents (list of names and addresses) to a certain individual and assumed that it was given to the Jury.

#### UPDATE FROM POINTE COUPEE CHAMBER OF COMMERCE

Secretary Martin announced this item was removed from the agenda by Mr. Richard Maciasz and will be rescheduled for another date.

# <u>DISCUSS AND TAKE ACTION WITH REGARDS TO TASKING SPECIAL COUNSEL FOR</u> REGARDS TO CLOSURE OF FALSE RIVER

Juror Olinde gave an update and history of the closure of False River to boat traffic dated back to 1979, 1983 and 1986, and that the Jury has been closing the river when the level reached 18 ft. He asked approval of the Jury to task Attorney Dannie Garrett as special counsel in regards to closure of False River to boat traffic at 18 ft. and reopen at 17.5 ft.

Attorney Garrett reported on a provision in Title 34, Section 851.27 that prohibits local regulations of water vessels and motor boats, which the state reserves that authority. He reported the act does allow the Jury to post speed limits and no wake zones by ordinances. Title 33, Section 1236.25 specifically gives the Jury the authority to regulate piers, bulkheads, docks and other constructions into False River. He reported the Jury could amend their Code of Ordinances to include the closure and regulations of public and private boat launches to access False River. He also reported on the Jury requesting the legislators to amend the State Statute Title 33, Section 1236.25 to add a paragraph that specifically gives the Jury authority to close False River to boat traffic for safety reasons.

Motion by Mr. Olinde and seconded by Mrs. Bueche:

RESOLVED, That Attorney Dannie Garrett be tasked as special counsel to craft an ordinance to amend the Code of Ordinances regarding the closure and regulations of public and private boat launches to access False River.

Unanimously carried.

Vice President Olinde gave an update on False River, and reported one (1) gate is open and the water level is 16.0 ft. He reported the drawdown on the river began today.

Juror Hurst recommended the Jury tables increasing the Drainage Impact Fee (DIF) until the sunset clause expires and review this matter in December.

Chairman Cox questioned the substitute motion that excludes the increase in the DIF and stressed how the Jury is going to pay invoices with limited funds available at the end of the year. He commented on the urgency and need to increase the DIF at this time that would lessen the impact on the Jury to allow more options for additional revenues. In closing, he gave an overview of the current finances.

Treasurer Mayeux reported the Jury has a cash balance of \$280,000, and after payroll tomorrow the balance will reduce to \$175,000.

Motion by Mr. Cox and seconded by Mr. Olinde:

Motion by Mr. Bazile and seconded by Mr. Olinde:

RESOLVED, That proposals be obtained to assess building damages caused by the flood at the Museum, Courthouse, Detention Center, NRCS and all eligible projects, pending the assessment is 100% refunded by FEMA.

The President called for a roll call vote that resulted as follows:

YEAS: Messrs. Bazile, Hurst, Langlois, Watkins, Taylor and Olinde.

NAYS: Messrs. Cox and Cline.

ABSTAIN: Mr. Dukes.

ABSENT: Mr. Jarreau, Mrs. Bueche and Mr. Smith.

On a vote of 6-2-1-3, the motion carried.
