<u>DISCUSSION & CONSIDERATION OF SELECTING A FIRM TO PERFORM ENGINEERING</u> & LAND SURVEYING SERVICES FOR THE HAZARD MITIGATION GRANT PROGRAM FOR THE AUGUST 2016 FLOOD EVENT

The Jury discussed the recommendations from a Selection Review Committee meeting held October 17, 2017, for the selection of a firm to perform engineering & land surveying services for the Hazard Mitigation Grant Program for the August 2016 flood event. After a lengthy discussion, the following resolution was offered:

RESOLVED, That upon review of the Request for Qualifications and recommendations by the Selection Review Committee, Professional Engineering Consultants Corporation, who received the highest points, be chosen for engineering & land surveying services for the Hazard Mitigation Grant Program for the August 2016 flood event in the parish.
